### Description

Insecticide for the control of **Aphids, Whiteflies** and **Thrips** on **Roses, Aphids, Thrips, Whiteflies** and **Caterpillars** on **Pepper, Thrips, Aphids** and **Caterpillars** on **French Beans** and **Broccoli, Thrips, Aphids, Caterpillars** and **Melon Fly** on **Cucumber**.

### Mode of Action

Is a broad spectrum non systemic and synthetic pyrethroid with contact and stomach action that has a quick knock down, repellent and anti-feeding activity.

Roses	Aphids, Whiteflies Thrips	0.5 L/Ha/1000L of water; (10 ml/ 20L of water)	Apply when the pests appear and repeat at 10 days interval if necessary. Three application in a season as recommended.
Pepper	Aphids, Thrips, Whiteflies & Caterpillars	250ml/ha/ 1000L of water, (5ml/20 L of water)	
Broccoli	Thrips, Aphids and Caterpillars
