Rate of Application

Rate of Application		
Crops	Dose	Application Stages
Vegetables	3 - 5 kg/Ha	All along the vegetative Cycle. Start one week after transplanting and split the total close dose in 3 - 4 applications every10 - 15 days.
Fruittress, Citrus	100 - 200 g/Tree	Since the growth starting to fruit swelling.
Vineyard	25 - 50 g/Plant	From the start of the Fertilization during 2 months, split the total close in 2 - 3 applications every 2 week.
Subtropical Crops	3 - 5 kg /Ha	All along the vegetative cycle until the end.
Cutflower	3 - 5 kg /Ha	All the long the vegetative cycle.

Mixing Instractions

Add Hum 3 slowly under continuours stirring with small quantity in enough water until reaching the total solubilazation of the product. The mentioned indicated doses and application stages are subject to soil and climatic conditions, influence of previous crops and other specific conditions.









Incopatibilities

Humus 3 is compatible with the most of products of the market. Incase of doubt, please make a test before general treatment.
